The Provider shall provide schooling services for the days and times listed below.

This schedule shall be in effect unless terminated by one of the parties in accordance with this Contract.

TUITION

The Parent(s) shall pay child care fees based on the above schedule at the rates specified below.

Fees for FULL time schooling are \$185 per week (Monday-Thursday)

# TIMING AND METHOD OF PAY

The Parent(s) shall pay school fees on or before the Friday before their summer session begins. If fees are not paid in full and on time, the Parent(s) agrees to pay a \$25 per day late fee. If fees are not paid by the first day of their session, the child(ren) will not be allowed to attend the facility until payment is received in full.

The Parent(s) agrees to pay a \$25 fee for all returned checks. If a check is returned unpaid, checks will no longer be accepted. Tuition will need to be paid with cash, check, or Venmo.

If any payment obligation under this Contract is not paid when due, the Parent(s) agrees to pay all costs of collection, including reasonable attorney fees, whether or not a lawsuit is commenced as part of the collection process.

### REGISTRATION FEE

The Parent(s) shall pay \$\_\_\_\_25\_\_\_\_ per child as an initial registration fee, per week when this contract is signed. The registration fee is non-refundable, non-transferable, and is applied to any school fees.

### INITIAL

### OVERTIME FEES

The Parent(s) agrees to pay overtime fees of \$5.00 per minute if the child(ren) is not picked up by the scheduled time as noted above. If the child(ren) is not picked up within 5 minutes after the scheduled time, the per minute overtime fee will start accruing from the scheduled time. This overtime fee shall be paid when the Parent(s) picks up the child(ren).

INITIAL

TRIAL PERIOD AND TERMINATION OF CHILD CARE.

The first 2 weeks of enrollment at this institution are considered a "trial period." Schooling may be terminated by either the Provider or the Parent(s) during this trial period without advance notice. After the trial period has passed, child care may be terminated by the Parent(s) only by providing the institution with 30 days advance written notice. If the Parent(s) or guardian(s) fails to provide a 30 day written notice after the trail period has passed, the Parent(s)/guardian(s) agrees to pay the regular scheduled fees for 2 weeks or portion of such 2 weeks immediately after such notice during which the Provider had no notice of such termination. Agape Educational Services retains the right to terminate this Contract without notice for the following reasons:

A) The child(ren)'s behavior is destructive, uncontrollable, violent, or threatening to the other children or providers at the school. This determination is made in the sole discretion of the Provider.

B) A Parent's behavior is threatening or abusive to the other children or providers at the school.

C) Child care fees are 10 days or more delinquent.

D) The child(ren) is absent for 10 days days or more without reasonable explanation or payment from the Parent(s).

All terminations of this type can be made effective immediately.

# SICK CHILD POLICY

If the child(ren) exhibits any of the symptoms listed below, the child(ren) shall not attend the child care facility until the symptoms are no longer exhibited or unless the Parent(s) has obtained a statement from the child's doctor stating that the child is not contagious. The final decision as to whether a child will be admitted to the school will be made in the sole discretion of the Provider. If the child(ren) exhibits any of these symptoms while present at the school, the Parent(s) will be notified and shall immediately remove the child(ren). The child(ren) may be isolated from the other children at the child care facility until the Parent(s) arrives. Symptoms Includes but not limited to:

- Lethargic
- Throws up more than once
  Shortness of breath

- White or Yellow Eye Discharge
- Mouth Sores along with drooling
  Earache, headache, sore throat or recent injury that makes it hard to play or sleep normally

The Parent(s) is responsible for arranging for alternate child care for closings when the Provider is attending training classes and for emergency closings due to severe weather school fees will be reduced proportionately for the days during which Agape Educational Services is closed.

## MODIFICATION OF TERMS

This institution shall be entitled to change any of the terms in this Contract, including but not limited to fees, by providing the Parent(s) with 30 days advance written notice of such changes.

# DAMAGE TO PROPERTY

Children are expected to treat all property located at the school with respect, including but not limited to toys and furniture. The Parent(s) agrees to pay for the accidental or willful destruction of any property located at the school, whether owned by Agape Educational Services or any other person, at the replacement cost, if such destruction was, in the sole opinion of Agape Educational Services, caused by the child.

#### DISCIPLINE

Agape Educational Services reserves the right to discipline a child when necessary. Discipline consists of: redirection and/or logical consequences.
